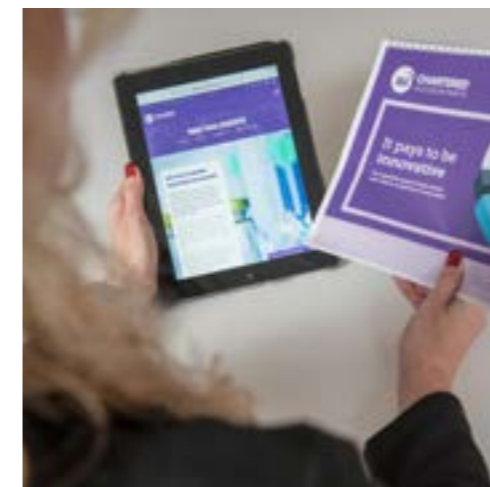

HMRC have recently been positively encouraging businesses to make claims for R&D activities and have introduced a scheme for companies to apply for advanced approval.

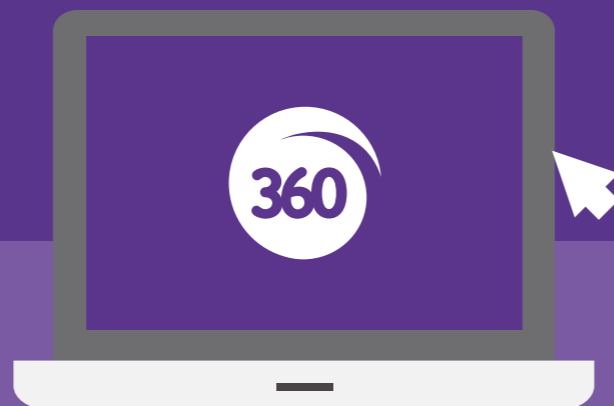

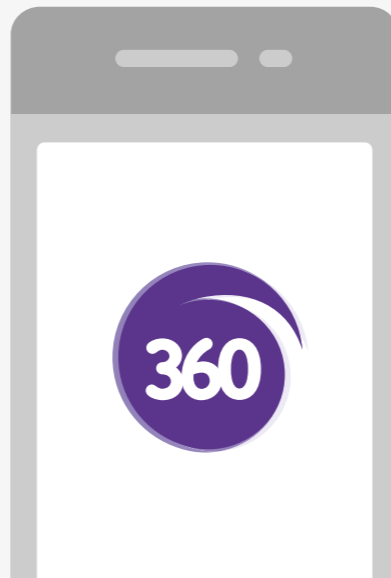
